The Ontario Public School Boards' Association (OPSBA) has long been a supporter of Local Government Week (LGW) as part of our advocacy work to increase and promote the importance of democratically and locally elected school board trustees. During the week of October 20 to 26, we asked our 31 member boards to promote civic awareness and the role of trustees among Ontario students, and in particular in Grade 5 and Grade 10 civics classes.

We updated resources to assist trustees in facilitating classroom sessions, including a Word document and a short PowerPoint presentation, which can be found at www.opsba.org. Part of our promotion was via Twitter using the hashtag #LocalGovWeek.
