Our world is no stranger to the outcomes of hate and discrimination. From WWII to the present day, the lessons to be drawn from hate are clear. This session will provide a foundational understanding of manifestations of hate and discrimination relevant to Ontario's publicly funded school boards. Participants will gain a deeper understanding of hate activities as well as an understanding of the impact of hate activity on students, staff and school communities.

The program will engage participants in discussions about how school boards can identify, prevent, and address discrimination and hate. The program will build on participants' practical skills to identify and address discrimination and hate activities (*Draft agenda - please see reverse side*).

Disability Rights in Public Education

Established in the early 1980s as a part of the Canadian Charter of Rights and Freedoms, also as a proceedion in the Ontario Human Rights Code, disability rights are an everyday part of publicly funded adulation.
