

2025 Provincial Party Election Platforms vs. OPSBA Priorities

During provincial elections, the Ontario Public School Boards' Association (OPSBA) advocates for non-partisan strategies to engage politicians in issues that focus on education and the well-being of children and youth. Election Day is Thursday, February 27, 2025, and OPSBA will be advocating to ensure public education remains a top election issue and encouraging school board trustees to attend any provincial *All Candidates Meetings* in their ridings across the province.

In addition, OPSBA has contacted the four major political party leaders and shared a questionnaire with a series of questions for the parties to answer.

- This summary of information is based on party answers to OPSBA's questionnaire, official party platforms/releases, media clips and party announcements made as of *February 21, 2025*. The chart attempts to compare our Multi-Year Strategic Priorities against party platforms based on available information and may not contain all information. The order of the parties listed is based on current party standings at Queen's Park.
